## LigoLab Go-Live December 15, 2025

South Bend Medical Foundation is pleased to announce that we will begin utilizing LigoLab, our new cloud-based laboratory information system, on **December 15**, **2025**. We request that you hold all specimens after **6pm on Friday**, **December 12**<sup>th</sup> until **Monday Dec 15**<sup>th</sup> **at 5am**. At 5:00 am on December 15<sup>st</sup> you will be able to enter all specimen orders into LigoLab, and send the specimens with the first courier that day.

Effective December 12, 2025 at 6 pm, POA will no longer be available for client use for ordering. Our new enhanced Client Portal will be available as its replacement. LIGO Connect Clients will use the Client Portal to access patient results. In addition to the Client Portal, SBMF will continue to offer automatic faxing as additional options for receiving reports. POA will still be available until December 31, 2025 to retrieve results on cases entered before 6pm on December 12, 2025.

Instructions on how to login and utilize Client Portal will follow this Client Notice. Please note that all login ID's are the same as POA. Your password has been set to Password1!, once you have logged in it will require you to change your password. From there you can create your own password.

Our team has worked diligently to ensure our clients experience a smooth transition.
